

City of Chattanooga

MAYOR

- shall be a resident of the City of Chattanooga for at least one year prior to his or her election
- shall be at least thirty (30) years of age

JUDGE

- shall be a licensed attorney authorized to practice in the courts of this state
- shall be for at least one year next before his election a citizen of Tennessee and a resident of said city

COUNCIL

- shall be at least twenty-one (21) years of age and a resident of the district for at least one year preceding his or her election

City of Collegedale

JUDGE

- shall be a licensed attorney authorized to practice in the courts of this state
- shall be not less than thirty (30) years of age and shall be a resident of the county within which the city lies

COMMISSION

- shall be a qualified voter of the city

City of East Ridge

JUDGE

- shall be at least thirty (30) years of age and a person licensed to practice law in the State of Tennessee
- shall before his election have been a resident of the State for five (5) years and of the City of East Ridge at least one year prior to his qualification for office
- shall not have been convicted of a crime involving moral turpitude
- shall hold no other elected office, either Federal, State, County or Municipal

MAYOR AND COUNCIL

- shall be residents and registered voters of the City of East Ridge for a least one year before their election
- shall be at least twenty-one (21) years of age
- shall have never suffered a conviction of any crime involving moral turpitude

COURT CLERK

- shall be a resident and registered voter of the City for at least one year before his election
- shall be at least twenty-one (21) years of age
- shall have never suffered a conviction for any crime involving moral turpitude

City of Lakesite

COMMISSION

- shall be a qualified voter of the city

Town of Lookout Mountain

JUDGE

- shall be a lawyer licensed to practice law in the State of Tennessee
- shall be at least thirty (30) years of age
- shall have been a resident of the State of Tennessee for five (5) years prior to the election and a resident of the Town of Lookout Mountain for one year prior to the election

COMMISSION AND SCHOOL BOARD

- shall be a resident of, and qualified voter in the town and shall have been such for one year next preceding his election

City of Red Bank

JUDGE

- shall be a licensed attorney authorized to practice in the courts of this state
- shall be not less than thirty (30) years of age and a resident of the county within which the city lies

COMMISSION

- shall be a qualified voter of the city and a resident of the district

City of Ridgeside

COMMISSION

- shall have been for at least one year next preceding his election a citizen of Tennessee and a resident of said city

Town of Signal Mountain

JUDGE

- shall be a registered voter in the town who is thirty (30) years of age and licensed to practice law in the State of Tennessee
- shall have been a resident of the State of Tennessee for five (5) years and a resident of the Town of Signal Mountain for one year

TOWN COUNCIL

- shall be a registered voter and resident of the Town

City of Soddy Daisy

JUDGE

- shall be a licensed attorney authorized to practice in the courts of this state
- shall be not less than thirty (30) years of age and a resident of the county within which the city lies

COMMISSION

- shall be a qualified voter of the city

Town of Walden

MAYOR AND ALDERMAN

- shall be a resident within the municipality for at least one year next preceding the election
